**GENERAL ORDER RE: IMPLEMENTATION OF EMERGENCY RELIEF
AUTHORIZED PURSUANT TO GOVERNMENT CODE SECTION 68115 BY CHAIR
OF JUDICIAL COUNCIL**

Exercising the authority granted under Government Code section 68115 and the March 17, 2020 Order (“Order”) of Chief Justice Tani G. Cantil-Sakauye, Chair of the Judicial Council of California, issued in response to the March 16, 2020 request for an emergency order made by the Superior Court of San Joaquin County (“Court”), this Court HEREBY FINDS AND ORDERS AS FOLLOWS:

For purposes of computing time for filing papers with the Court under Code of Civil Procedure sections 12 and 12a, 10 court days, or from March 17, 2020, to March 30, 2020, inclusive, are deemed holidays. (Gov. Code, § 68115(a)(4));

For purposes of computing time under Penal Code section 825, and Welfare and Institutions Code sections 313, 315, 631, 632, 637, and 657, from March 17, 2020, to April 5, 2020, inclusive are deemed holidays (Gov. Code, § 68115(a)(5));

For purposes of computing time for filing papers with the Court under Welfare and Institutions Code section 334, 10 court days or from March 17, 2020 to March 30, 2020, inclusive, are deemed holidays. (Gov. Code, § 68115(a)(5));

In cases in which the statutory deadline otherwise would expire on from March 17, 2020 to April 5, 2020, inclusive, any judge of the Court may extend the time periods provided in sections 583.310 and 583.320 of the Code of Civil Procedure to bring an action to trial by not more than 30 days (Gov. Code, § 68115(a)(6));

Any judge of the Court may extend by not more than 30 days the duration of any temporary restraining order that would otherwise expire within 14 days, because the emergency condition described in the Order prevented the Court from conducting proceedings to determine whether a permanent order should be entered (Gov. Code, § 68115(a)(7));

In cases in which the statutory deadline otherwise would expire on March 17, 2020, to April 3, 2020 inclusive, any judge of the Court may extend the time period provided in

1 section 825 of the Penal Code within which a defendant charged with a felony offense must be
2 taken before a magistrate from 48 hours to not more than 5 days (Gov. Code, § 68115(a)(8));

3 In cases in which the statutory deadline otherwise would expire from March 17, 2020, to
4 April 17, 2020, inclusive, any judge of the Court may extend the time period provided in
5 section 859b of the Penal Code for the holding of a preliminary examination from 10 court days
6 to not more than 15 court days (Gov. Code, § 68115(a)(9));

7 In cases in which the statutory deadline otherwise would expire from March 17, 2020, to
8 April 3, 2020, inclusive, any judge of the Court may extend the time period provided in
9 section 1382 of the Penal Code for the holding of a criminal trial by not more than 30 days (Gov.
10 Code, § 68115(a)(10));

11 In cases in which the statutory deadline otherwise would from March 17, 2020, to April
12 3, 2020, inclusive, any judge of the Court may extend the time period provided in section 313 of
13 the Welfare and Institutions Code within which a minor taken into custody pending dependency
14 proceedings must be released from custody to not more than 5 days (Gov. Code,
15 § 68115(a)(11));

16 In cases in which the statutory deadline otherwise would expire from March 17, 2020, to
17 April 3, 2020, inclusive, any judge of the Court may extend the time period provided in
18 section 315 of the Welfare and Institutions Code within which a minor taken into custody
19 pending dependency proceedings must be given a detention hearing to not more than 5 days
20 (Gov. Code, § 68115(a)(11));

21 In cases in which the statutory deadline otherwise would expire from March 17, 2020, to
22 April 3, 2020, inclusive, any judge of the Court may extend the time periods provided in
23 sections 632 and 637 of the Welfare and Institutions Code within which a minor taken into
24 custody pending wardship proceedings and charged with a felony must be given a detention
25 hearing or rehearing to not more than 5 days (Gov. Code, § 68115(a)(11));

26 In cases in which the statutory deadline otherwise would expire from March 17, 2020, to
27 April 3, 2020, inclusive, any judge of the Court may extend the time period provided in
28 section 334 of the Welfare and Institutions Code within which a hearing on a juvenile

1 dependency petition must be held by not more than 15 days (Gov. Code, § 68115(a)(12)); and

2 In cases in which the statutory deadline otherwise would expire from March 17, 2020, to
3 April 3, 2020, inclusive, any judge of the Court may extend the time period provided in
4 section 657 of the Welfare and Institutions Code within which a hearing on a wardship petition
5 for a minor charged with a felony offense must be held by not more than 15 days (Gov. Code,
6 § 68115(a)(12)).

8 It is also Ordered that each Judicial Officer of the Superior Court of San Joaquin County
9 is hereby deputized to effectuate all of the above provisions.
